To The Principals All Affiliated Institutes of Hotel Management (Central, State, PSU & Private IHMs)

Sub: Admission into the UG and PG programs of NCHMCT recognized by JNU for a 2024.

Sir/Madam.

This has reference to the subject cited above in connection with the past experience of admission into the above said programs. As we all are aware that presently, students are enrolled into both the abovesaid programs under Jawaharlal Nehru University (JNU), New Delhi. As such, we have to follow all the instructions of the Unviersity and also honour any other instructions issued by the University regarding admission. During the admission 2023, about 2200 students admitted directly on the initiative of individual institute and also under various states quota, over and above the admission done through centralized counselling process. While registering of admitted candidates of 2023, JNU has given this Council a strict instruction that from 2024 onward, no direct admitted student be allowed for registration with JNU in there two programs.

- In view of the above restriction imposed in the admission of abovesaid two programs, the Council is now compelled to take admission and through entrance examination. As you are aware that NCHM JEE is conducted by NTA and after getting the result from NTA, the Council conduct centralized counselling process for allotment of Institute. In addition to that, the Institutes are also given permission to fill the residual vacancies by following the prescribed parameters as approved by the Board of this Council.
- On putting restrictions by JNU, which is the degree awarding University, the NCHMCT has to conduct a subsequent entrance examination (either online mode or physical mode) for the candidates marketed and admitted by the individual institutes. The examination pattern will be on a similar to NCHM JEE. This formality of subsequent entrance examination by NCHMCT now became mandatory as per the above said instruction of JNU. Therefore, it should be noted by all the Institutes, already started marketing of direct admission, that all such candidates to where they are offering provisional admission should appear for the subsequent entrance examination, probably to be conducted at the end of July 2024 either through online mode or physically at the institute where they are taking admission. Their provisional admission can only be confirmed after they qualify the subsequent entrance examination. All the Institutes are therefore instructed to inform the interested candidates for direct admission to their Institute, that everyone has to undergo an entrance examination to

- 4. It is to inform to all the Institutes that this year (2024), total enrolment into NCHM JEE is 15279 only and as per earlier experience, appearance in JEE will not be more than 12500. As such, it is expected that the Institutes should initiate their individual efforts to fill residual vacancies to avoid wastage of infrastructure and financial loss. Approval on the percentage of seats to be filled by direct admission will be issued separately. However, the instruction as stated above regarding compulsorily appearance into the subsequent entrance examination will be mandatory for such direct admitted candidates.
- The above points should be followed strictly.
